

## DRINKING WATER INFORMATION

The sources of drinking water (both tap water and boiled water) included rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animal or human activity. Contaminants that may be present in source water include:

Microbial contaminants, such as viruses and bacteria which may come from sewage treatment plants, septic systems, agricultural livestock operation and wildlife.

Inorganic contaminants, such as salts and metals which can be naturally-occurring or results from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.

Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.

Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum productions, and can also come from gas stations, urban stormwater runoff and septic systems.

Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

## SPECIAL HEALTH INFORMATION

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised people such as



people with cancer undergoing chemotherapy, people who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. ## THE WATER YOU DRINK

In order to ensure that tap water is safe to drink the U.S. Environmental Protection Agency, EPA, prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Duluth is responsible for providing high quality drinking water, but cannot control the materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ## DRINKING WATER REPORT

The City of Duluth is issuing the results of monitoring done on its drinking water for the period from January 1 to December 31, 2016. The purpose of this report is to inform consumers on laboratory testing of the drinking water and heighten awareness of the need to protect precious water resources.

## RESULTS OF MONITORING

This year again brings good news: No contaminants were found at levels that violated federal drinking water standards. The table on the right shows the contaminants that were detected in trace amounts last year.



## LAKE SUPERIOR SUPPLIES DULUTH WITH DRINKING WATER

The source water supply for the City of Duluth is a surface water source: Lake Superior. The Minnesota Department of Health has determined that one or more sources of your drinking water are susceptible to contamination. \*This is the value used to determine compliance with federal standards. \*\*Follow-up sampling was conducted at sites exceeding the action level. The results for each site were averaged and after this calculation, 3 sites out of 60 remained over the action level.

## KEY TO ABBREVIATIONS:

**MCLG ~ Maximum Contaminant Level Goal:** The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**MCL ~ Maximum Contaminant Level:** The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

The MCL for lead and copper is known as the Action Level (AL). This is the concentration of a contaminant which, when exceeded, triggers treatment or other requirements which a water system must follow. Ninety percent of the samples tested must be less than the Action Level for compliance.

Some contaminants do not have Maximum Contaminant Levels established for them. These "unregulated contaminants" are assessed using state standards known as health risk limits to determine if they pose a threat to human health. If unacceptable levels of an unregulated contaminant are found, the response is the same as if an MCL has been exceeded; the water system must inform its customers and take other corrective actions.

**90th Percentile Level ~** This is the value obtained after disregarding 10% of the samples taken that had the highest levels.

## OTHER DEFINITIONS:

### AL ~ Action Level

The concentration of a contaminant which, if exceeded, triggers treatment or other requirement which a water system must follow.

### pCi/L ~ PicoCuries per liter

A measure of radioactivity.

### TT ~ Treatment Technique

A required process intended to reduce the level of contaminants in drinking water.

### ppb ~ Part per billion

Also expressed as micrograms per liter (ug/l).

### ppm ~ Part per million

Also expressed as milligrams per liter (mg/l).

### nd ~ Not detected.

### MRDL ~ Maximum Residual Disinfectant Level

### MRDLG ~ Maximum Residual Disinfectant Level Goal

### NTU ~ Nephelometric Turbidity Units

Used to measure clarity in drinking water.

### N/A ~ Not applicable/Does not apply.
